

MAGICAL STROLLER LLC

RENTAL AGREEMENT

Effective Date: August 2026

This Rental Agreement ("Agreement") is entered into between **Magical Stroller LLC** ("Magical Stroller," "we," "our," or "us") and the individual renting equipment ("Renter," "you," or "your").

By placing an order, accepting delivery, or using any rented equipment, you agree to be bound by this Agreement.

1. Rental Equipment

This Agreement applies to all equipment rented from Magical Stroller LLC, including but not limited to:

- Single strollers
 - Double strollers
 - Jogging strollers
 - Mobility scooters
 - Accessories
 - Rain covers
 - Parent consoles
 - Cup holders
 - Cooler bags
 - Child trays
 - Any additional rented equipment

2. Rental Period

The rental period begins when the equipment is delivered.

The rental ends at the scheduled pickup time.

Late returns may result in additional rental charges.

3. Delivery and Pickup

Magical Stroller delivers and retrieves equipment at approved locations.

The Renter agrees to:

- Provide accurate delivery information.
- Be available during the selected delivery window when required.
- Return the equipment in the agreed pickup location.
- Notify Magical Stroller immediately if pickup arrangements need to change.

Failure to return equipment may result in additional fees.

4. Condition of Equipment

All equipment is professionally cleaned, sanitized, and inspected before every rental.

The Renter agrees to inspect the equipment upon delivery.

Any issue must be reported within **2 hours** of delivery.

Failure to report an issue constitutes acceptance of the equipment in good condition.

Photographic Documentation

Magical Stroller LLC may photograph or video record the rented equipment immediately before delivery and immediately after pickup. Such photographs or videos may be used as evidence of the equipment's condition in the event of any dispute regarding damage, cleanliness, missing accessories, or misuse.

5. Proper Use

The equipment shall be used only for its intended purpose.

The Renter agrees to:

- Follow all manufacturer instructions.
 - Never exceed the manufacturer's weight limits.
 - Never allow more than the permitted number of children.
 - Never modify the equipment.
 - Never tow, pull, or attach the stroller to another vehicle.
 - Use all safety restraints.

6. Supervision

Children must never be left unattended.

The Renter assumes full responsibility for supervising all children using the rented equipment.

7. Prohibited Uses

The equipment may not be used:

- On beaches or in ocean water.
 - In saltwater.
 - During off-road activities.
 - For commercial purposes.
 - By anyone under the influence of alcohol or drugs.
 - In any manner inconsistent with manufacturer recommendations.

8. Responsibility for Loss or Damage

The Renter is responsible for the equipment from delivery until pickup.

Unless covered by the **Magical Care Protection Plan**, the Renter agrees to pay for:

- Repairs
- Replacement parts
- Excessive cleaning
- Missing accessories
- Replacement of lost equipment
- Full replacement when the equipment cannot be repaired

Repair and replacement charges shall be determined in accordance with Appendix A – Damage & Replacement Fee Schedule. The fees listed are estimates only. If the actual reasonable cost of repair or replacement exceeds the estimated amount due to manufacturer pricing, labor, shipping, taxes, or parts availability, the Renter agrees to pay the actual documented cost incurred by Magical Stroller LLC.

Normal wear and tear resulting from ordinary use is expected and will not be charged to the Renter.

9. Theft or Loss

If equipment is stolen or lost, the Renter must:

- Notify local law enforcement immediately.
- Obtain a police report.
- Notify Magical Stroller within **24 hours**.

Failure to do so may result in full replacement charges.

10. Cleaning

Normal cleaning is included.

Excessive dirt, sand, food residue, bodily fluids, mold, smoke odor, or other unusual contamination may result in additional cleaning charges.

11. Payment Authorization

The Renter authorizes Magical Stroller LLC to charge the payment method on file for:

- Outstanding rental charges
- Late return fees
- Cleaning charges
- Repair costs
- Replacement costs
- Missing accessories
- Any other charges authorized under this Agreement

Receipts will be provided upon request.

Chargeback Policy

If the Renter disputes a valid charge through their credit card issuer without first contacting Magical Stroller LLC to resolve the matter, Magical Stroller LLC reserves the right to provide this Agreement, inspection reports, photographs, delivery records, and repair documentation to the payment processor or financial institution as evidence supporting the charge.

12. Safety Disclaimer

The Renter acknowledges that all equipment carries inherent risks.

Magical Stroller cannot guarantee that accidents will never occur.

The Renter assumes all risks associated with the use of the rented equipment.

13. Limitation of Liability

To the fullest extent permitted by Florida law, Magical Stroller LLC shall not be liable for:

- Personal injury
- Death
- Property damage
- Indirect damages
- Incidental damages
- Consequential damages
- Lost vacation time
- Missed reservations
- Lost tickets
- Lost income

Our total liability shall never exceed the amount paid for the rental.

14. Indemnification

The Renter agrees to defend, indemnify, and hold harmless Magical Stroller LLC, its owners, employees, contractors, and agents from any claims, damages, liabilities, costs, or expenses arising out of the use or misuse of the rented equipment.

15. No Warranty

All equipment is rented "**AS IS**", except that Magical Stroller warrants that it has been inspected and is in safe operating condition at the time of delivery.

No additional warranties, express or implied, are provided.

16. Force Majeure

Magical Stroller shall not be liable for delays or failures caused by events beyond our reasonable control, including severe weather, hurricanes, floods, government actions, road closures, labor disputes, or other unforeseen events.

17. Cancellation Policy

Cancellation and refund eligibility are governed by Magical Stroller's separate **Cancellation Policy**, which is incorporated into this Agreement by reference.

18. Magical Care Protection Plan

If purchased, the **Magical Care Protection Plan** forms part of this Agreement and is governed by its own terms and conditions.

19. Governing Law

This Agreement shall be governed by and interpreted under the laws of the **State of Florida**, without regard to conflict of law principles.

Venue for any legal action shall lie exclusively in the state or federal courts located in Florida.

20. Electronic Acceptance

By placing an order through our website, signing electronically, or accepting delivery of the rented equipment, the Renter acknowledges that they have read, understood, and agreed to this Agreement.

Electronic acceptance shall have the same legal effect as a handwritten signature.

21. Entire Agreement

This Agreement, together with the Magical Care Protection Plan, the Cancellation Policy, the Delivery & Pickup Policy, the Privacy Policy, the Terms of Use, and the

Damage & Replacement Fee Schedule, constitutes the entire agreement between the parties and supersedes all prior discussions or understandings relating to the rental.

DAMAGE & REPLACEMENT FEE SCHEDULE

Full Replacement Charges
